



Chairman Lopes and McGee, Ranking Members Circarella and Polletta, thank you for giving me the opportunity to speak on proposed Bill # 6408 and express my firm opposition to this proposed change to voter registration guidelines already in place.

As the Founder and CEO of Fight Voter Fraud Inc, a 501 (c) 4 nonprofit organization, we firmly believe in “One vote for one legal voter. ©”. In the State of Connecticut, this is not happening. The Secretary of the State, Denise Merrill, has failed the public in making sure we have “clean” voter rolls.

Before we can entertain making additional changes to how eligible voters are allowed to register to vote and opening up the process to yet another agency whose primary mission is not to register eligible citizens to vote and then give them to another agency who has clearly had issues in the registering process, we need to clean & maintain (per Federal law) the voters rolls of people that no longer live in the State of CT, of those that have passed away, (almost 11,000 as of December 2019 per data from the Public Interest Legal Foundation’s Amicus brief filed in the CT Supreme Court in July 2020 and sent to the Secretary of the State at the same time.) yet are still on the active voter list and identify and remove the 200,000+ inactive voters, we first need to again, clean the voter rolls.

The focus should be to ensure only the eligible to voters are allowed to vote in the State of Connecticut. This is not happening. According to the data base records maintained by the Secretary of the State, 1555 people with the same birth date, first name, last house and street have two (2) voter ID numbers. 104 voted twice. 104 committed felonies and deprived the legitimate voter of their right to a fair election. 6 (six) people under the age of 18 voted in the November 3rd 2020 election. These numbers are right in the Secretary of the States database and easy to see. 2650 people voted in person and absentee according to the Secretary of the States database.

There are 101923 people registered to vote with the birth date of January 1, 1800.



In our research of Connecticut voters to date, we've already found scores of Connecticut voters that voted not only in Connecticut this past election, but voted in numerous other States, as well. The Integrity of the voter rolls and how they are maintained is clearly in question. When we are ready, we will bring forward the proof of all the individuals that have negated our votes.

In the meantime, it is not just a bad idea to entertain adding another agency in charge of registering people to vote through another process, it will further disenfranchise the legitimate voters. Instead of focusing on how many more names can be put to the voter rolls in Connecticut, force the Secretary of the State, Denise Merrill to clean her own house, to do the job she was elected to do. Clean the voter rolls, offer more training to the local Registrars, stopping tying their hands and directing them not to do canvassing, as was done last year before Covid 19.

Why would you want to expand and cause more confusion than already exists with the voter rolls in CT by adding another agency into the mix?

In conclusion, fix the broken system before adding another layer of bureaucratic ways to muddy the already blackened water of a fair and clean election process. Vote against wasting more resources and tax payer dollars and "Clean the voter rolls."
